Important information for visitors of The University of Chicago Francis and Rose Yuen Campus in Hong Kong.

Health and Safety measures

Visitors understand that by accessing the UChicago Yuen Campus Hong Kong, they will have to comply with the UChicago Yuen Campus Hong Kong health and safety precautionary measures.

In order to access UChicago Yuen Campus Hong Kong, visitors will need to declare that they:

- do not have any Covid symptoms (including but not limited to fever, cough, sore throat)
- are not required to undergo the government-required 14 days quarantine and medical surveillance.
- are not required to undergo the government-required 3 days medical surveillance after Inbound travel.
- have not been in contact with anyone who is suspected / confirmed to have COVID-19 in the past 7 days.
- have not been in contact with anyone who is required to undergo a 14-day self-quarantine in the past 7 days.
- are required to wear mask at all times when they are inside the campus building.

Before Arriving The Campus

During the current period of increased COVID cases, we will require <u>DAILY NEGATIVE COVID test results</u> using rapid test kits. Please take a photo of the test kit with information of date and time of the test. Please show the security guard this photo image (sample below) upon arrival to campus. Please keep this photo record for 30 days on your personal mobile device.



What To Expect When You Arrive On Campus:

All visitors who arrive on campus must be wearing a mask to be allowed access to the building. If you are not wearing a mask when you arrive, you will be denied entry to the building.

Upon entry, you must **first wash hands in first floor bathrooms** before checking in. After you **wash your hands**, you must **register at the front desk** with below steps:

Vaccination Status: All visitors are allowed access to the Yuen Campus after a campus security guard verifies
"vaccination" or "vaccination exemption" status by scanning your QR Code in the "Leave Home Safe App" in
compliance with the Hong Kong Government vaccine pass requirement.

Visitors with a Red or Amber Code are not allowed to enter the campus.

2. **Covid Rapid Testing:** Please show the security guard of your **DAILY NEGATIVE COVID test results** (which mentioned in above) upon arrival to campus.

No campus parking will be available to any visitors at any time.

Rules Everyone Must Follow While on Campus

Please adhere to the on-campus rules below. If you are not adhering to the rules, you will be asked to leave the campus.

Masks and Social Distancing guidelines

- 1. Masks are required on campus at all times
- 2. Maintain social distance (1 meter with masks on; 1.5 meters while eating and drinking) between visitors.
- 3. You are allowed access only to the designated areas. There will be no access to other parts of the campus.
- 4. Do not loiter or congregate in public spaces

If You Fall Ill

- 1. If you fall ill while visiting our campus, please notify the security guards at the reception immediately
- 2. Please stay home if you are ill.
- Seek medical attention if needed
- 4. If you have symptoms associated or confirmed with COVID-19 within 14 days after your visit to the campus, please notify the campus at hk@uchicago.edu or call +852 2533 9400

Privacy

- 1. Communications about sick visitors will follow local privacy laws
- 2. Data collected when registering for visit on campus will be destroyed 90 days after the time the data is collected

Continued Monitoring of the COVID-19 Situation

Visitors should be prepared to change their plans on short notice if the situation with the coronavirus worsens and we need to close the campus completely.

We continue to monitor multiple metrics including the number of new cases, total cases and deaths from the virus as well as government guidelines for opening government offices, schools, etc. If these metrics or government guidelines change and affect our campus **opening** plan, we will notify you immediately.

芝加哥大學香港校園的訪客須知:


健康和安全預防措施

訪客明白於進入芝加哥大學香港校園同時, 訪客需遵守芝加哥大學香港校園的健康與安全措施, 並作出下列 聲明以到訪香港芝加哥大學校園:

- 本人未有任何2019冠狀病毒病相關症狀(包括但不限於發燒,咳嗽,喉嚨痛);
- 本人並非需接受政府規定 14 天隔離和醫學監測的人仕。
- 本人並非需接受政府規定的入境旅行後3天醫療監測的人仕。
- 本人於過去 7 天内, 未曾與懷疑/確認患有 COVID-19 的人仕有接觸;
- 本人於過去7天内,未有與任何需要進行14天自我隔離的人仕有接觸;
- 本人在校園大樓内時,會時刻戴上口罩。

到訪校園前的準備

因應 COVID 病例的增加,所有到訪本校園的人士需出示當天的**快速檢測試劑的陰性檢測結果**。 請拍下展示檢測結果的測試套件照片,並附上姓名、測試日期和時間的資料。 抵達校園後,請向保安出示此照片(樣本如下)。請將此照片記錄並保存於您的個人移動設備上 30 天。



到訪校園時的程序

所有到訪者必須全程配戴口罩,方可進入大樓節圍。如訪客沒有戴上口罩,將被拒進入大樓。

進入大樓後, 訪客請先到洗手間清潔雙手, 然後辦理登記手續。潔手後, 訪客可於接待處先進行體溫檢測, 完成以下登記程序, 並由接待處人員核實即可進入活動或展覽區域。

1. **疫苗通行証**: 所有到訪者需於接待處掃描 "安心出行" 二維碼並由保安人員驗證該人士的 "疫苗接種" 或 "免疫苗接種" 狀態,以符合香港政府疫苗通過要求方可進入校園。

持有紅碼和黃碼的訪客不可以進入校園;

校園守則

訪客請遵守以下校園規則。否則,將被要求離開校園。

口罩及減少社交接觸指引

- 於校園内需全程配戴口罩;
- 與其他訪客之間保持社交距離(當配戴口罩時為不少於1米;當飲食時不少於1.5米)
- 只可進入指定活動區,校園大樓的其他部分並不對外開放;
- 請勿於校園的公共範圍聚集或長期逗留。

若身體不適:

- 如在到訪校園時身體不適,請即於接待處通知保安人員。
- 如有身體不適,請待在家裡。
- 必要時請盡快求診。
- 如到訪校園後 14 天内有與 2019 冠狀病毒病相關症狀或已確診人仕接觸, 請發送電子郵件至 hk@uchicago.edu 或致電+852 2533 9400 通知校方。

隱私

- 將根據香港的隱私條例與生病訪客的通訊
- 訪客的到訪資料將於收集數據日起 90 天後被銷毀

密切留意 2019 冠狀病毒的狀況

如果冠狀病毒的情況惡化,校方有權因應實際情況或依照政府指引下關閉校園。訪客需於短時間內取消或更改到訪行程。

校園將持續觀察多個指標;包括新的確診數字、病例總數、死亡人數,以及各個政府機關或學校開放指引等條件決定校園對外開放與否。如果這些指標的變化或政府的指引影響校園的開放情况,我們將立即通知您。
