### STUDYING THREATS TO MEMBERS OF CONGRESS



#### Nearly 400 charged threats by Dept of Justice and State Courts from 2001 to 2024

- Charged Threat Event: A threat or attack against a U.S. Representative or Senator charged in Federal or State Court
  - Federal charges include: Assaulting, kidnapping, murdering a US official or their family, or threatening to do so (18 U.S.C. § 115); Congressional, Cabinet, and Supreme Court assassination, kidnapping, and assault (18 U.S.C. § 351) Interstate communications of threats (18 U.S.C. § 875); Mailing threatening communications (18 U.S.C. § 876)
  - We include attacks where the perpetrator dies prior to charging, e.g. the attack 2017 attack on Congressional Republicans that injured Rep. Steve Scalise and other during which the assailant was shot and killed by police.
- Systematic search for threats to over 1,600 members of Congress (2001-2024) in opensource media and court records; charges confirmed in court records
  - Database contains number of Members threatened, perpetrators, perpetrator characteristics and motives
- Goal: CPOST study seeks to understand the changing trajectory, balance of target political identification, and perpetrator motives.


- Charged threats: 378
- Charged perpetrators: 265
- Perpetrators with multiple threats: 54
- Most threats by perpetrator(s):
  - Szabo and Radovanovic, Dec 2023 swatting campaign: 17
  - Vance Boelter, Minnesota 2024 assassination and hitlist: 14
  - James Hodgkinson, 2017 attack on Congressional baseball practice: 11
- Most threatened Democrat and Republican
  - Representative Nancy Pelosi (D-CA): 15 charged threats
  - Senator Susan Collins (R-ME): 5 charged threats

Threats to Members of Congress Up 600% in 2017 and Remain High



#### **Members of Congress from Both Parties Targeted**








#### Official data shows spike in threats in 2017

- Diversion




