It is understood the Artist(s) executes this agreement as an independent contractor and is not an employee of the "University", and that Artist(s) shall have the mutual control of the means, method and details of fulfilling obligations under this contract, except for performance time(s) minimum and maximum length of the act. Artist(s) agrees to perform and discharge all obligations as an independent contractor under any and all laws, whether existing or in the future, in any way pertaining to the engagement hereunder, including but not limited to Social Security laws, Workman's Compensation Insurance, Income Taxes, State Employment Insurance taxes or contributions. Public Liability Insurance and Artist(s) will hold the "University" harmless against any such laws as ell against all Union claims for welfare payments.

The Artist(s) will furnish all necessary costumes and equipment used by them in connection with the engagement, including amplification equipment and any special sound and lighting effects, unless otherwise noted above.

There is to be no consumption or use of alcoholic beverages or illegal se of drugs on the "University" campus by the Artist(s). If the Artist(s) or any of the performers arrive at the performance site noticeably under the influence of alcoholic beverages, narcotics, or drugs, the "University" may cancel the contract.

In the event that there are any riots, disturbances, rebellions, insurrections, strikes, labor difficulties, epidemics, any act or order of any public authority or any cause of similar or dissimilar beyond the "University's" control, in the City of Chicago, which could seriously affect the attendance and/or the continued performance, the "University" shall have the right to cancel this contract.

Artist(s) represent that in performing under the terms of this contract, they are not infringing on the property right, copyright, patent right on any other right of anyone else; and if any suit is brought or a claim made by anyone that anything in conjunction with the ownership or the presentation of said act or appearance is an infringement on the said acts, Artist(s) will indemnify the "University" against any and all loss, damage cost, attorney's fee or other loss whatsoever by reason of Artist(s) Representative or Agent permitting or allowing the presentation of the act or attraction called for herein.

The signer for the "University" warrants that he or she signs as a properly authorized representative of the "University" and does not assume any personal liability for meeting the terms of this contract.

No part, portion or segment of any engagement may be broadcast, recorded or reproduced either by audio or visual mean, without expressed written permission of the Artist(s) or their agent.

The "University" agrees that

Acting only as agent to the extent of furnishing Artist(s) to the "University", and any conflict pertaining to this contract shall be resolved by the Courts of the State wherein this engagement is to be performed.
