

CLINICAL MEDICAL ETHICS

The MacLean Center for Clinical Medical Ethics at the University of Chicago is the oldest and largest program in clinical ethics in the world and one of the oldest university bioethics programs in the United States. Clinical medical ethics is a field that examines the practical, everyday ethical issues that arise in encounters among patients, doctors, nurses, allied health workers, and health care institutions. The goal of clinical medical ethics is to improve patient care and outcomes. Since the founding of the MacLean Center in 1984, the Center has trained more than 400 fellows in a one year full-time or part-time program. Current and former MacLean Center fellows and faculty have published more than 210 books. In October 2013, the MacLean Center received the Cornerstone Award from the American Society for Bioethics and Humanities (ASBH) for “outstanding contributions from an Institution that has helped shape the direction of the fields of bioethics and/or medical humanities.” At the conclusion of this activity, the attendees will be able to do the following: discuss how clinical medical ethics applies broadly to the American healthcare system and specifically to their individual fields or specialties; explain how to apply the tenants of clinical medical ethics to the scenarios they encounter in their fields or specialties; and describe how current literature and directives in the field of clinical medical ethics will help them to make improved ethics decisions in their practice. This activity has been designed for physicians and other health care professionals interested in the field of clinical medical ethics.
