Grounds for IRC Review - Complaints relating directly or indirectly to issues of:

1. Excessive force; 2. Violation of rights; 3. Abusive Language; or 4. Dereliction of duty

Dispositions:

Unfounded: allegation is not factually accurate; alleged conduct did not occur.

Exonerated: alleged conduct did occur but was justified under the circumstances.

Sustained: alleged conduct did occur and was not justified under the circumstances

Not Sustained: written record of the investigation does not support a determination of whether alleged conduct occurred. A classification of "not sustained" is

Administratively Closed: no investigation was completed due to the fact that the complainant either (i) did not sign an affidavit for the investigation to
