



**Reports of Harassment, Discrimination and Sexual Misconduct  
Involving UChicago Students**

On an annual basis, the Office of the Dean of Students in the University will release statistics and information on reports from the previous academic year that allege harassment, discrimination and sexual misconduct involving students at the University, including matters heard by the University-wide Student Disciplinary Committee in which a student is the accused.

The data presented below derive from reports and formal complaints that were received between July 1, 2014 and June 30, 2017. For the purposes of this report, each academic year begins July 1 and ends June 30.

**Table I. Number of reports**

The table below indicates the number of unique reports where the complainant and/or respondent is a student at the University. A complainant may direct an allegation against more than one respondent, and there may be multiple complainants attached to one report.

\* Please note that just prior to the 2016-2017 academic year, the University hired a dedicated personnel position to manage all student reports of sexual misconduct. This hiring coupled with the mandatory campus-wide training on “responsible employee” disclosure obligations, University policy, and support/resources as well as the focused supplemental educational sessions for staff/organizations/departments who have direct student contact and therefore could be receiving higher incidents of disclosures may have resulted in the increase in reports.

**Table II. Types of issues reported**

Individual reports can include allegations of one or more behaviors that violate University policy. Definitions of these behaviors are provided in the University’s [Policy on Harassment, Discrimination and Sexual Misconduct](#). Because a report/complaint can allege multiple behaviors that are prohibited by the policy, the total number of issues may exceed the total number of reports/complaints.

**Table III. Resolutions/Remedies**

Student reports/complaints submitted to the [Title IX Coordinator](#) and/or [Associate Dean of Students in the University for Disciplinary Affairs](#) can be addressed in a [variety](#) of ways, including support/resources, interim measures, and/or a formal disciplinary hearing before the [University-wide Student Disciplinary Committee](#) (if the accused is a student and the reporting party requests moving forward with the formal disciplinary process). The table below lists the types of resolutions/remedies that were applied to reports submitted for the year(s) indicated. A complainant can request one or more resolutions/remedies during the report of a situation, and can return following the incident disclosure to access additional resolutions/remedies. This table captures all individual resolutions/remedies requested. ***Please note this table was updated in AY16/17 to more clearly articulate different resolutions, interim measures, remedies, and support/resources that may be provided to students.***

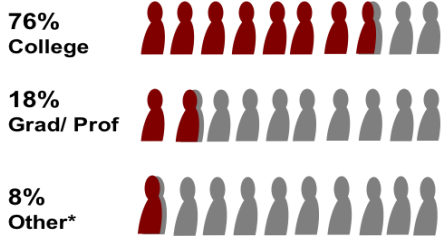
**Table V: Resolution of Reported No Contact Directive Violations**

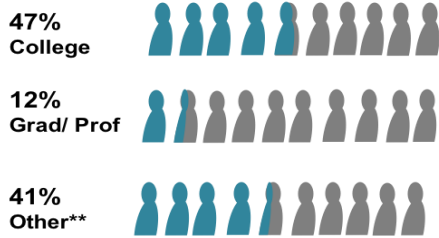
# Infographic Overview of Harassment, Discrimination & Sexual Misconduct Reports 2014-2017

## Status of Complainant in Sexual Misconduct Disclosures



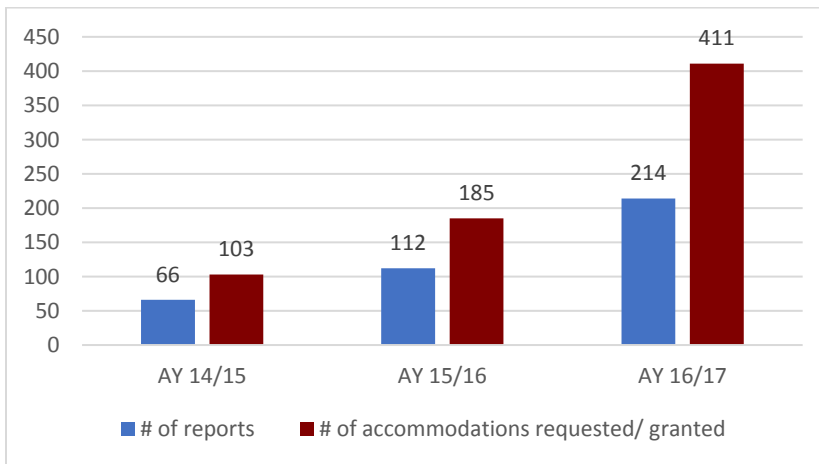
\*Other = 3% anonymous; 1% University-affiliated non-student; 4% unaffiliated
